BUYER'S INSOLVENCY OR INCAPACITY

If the Buyer becomes subject to any of the events listed in clause 7.2 or MQL reasonably believes that the Buyer is about to become subject to any of them and notifies the Buyer accordingly, then, without limiting any other right or remedy available to MQL, MQL may cancel or suspend all further deliveries under the Contract or under any other contract between the Buyer and MQL without incurring any liability to the Buyer, and all outstanding sums in respect of Livestock delivered to the Buyer shall become immediately due. A waiver of any right or remedy under the Contract is only effective if given in writing and shall not be deemed a waiver of any subsequent breach or default. No failure or delay by a party to exercise any right or remedy provided under the Contract or by law shall constitute a waiver of that or any other right or remedy, nor shall it preclude or restrict the further exercise of that or any other right or remedy. No single or partial exercise of such right or remedy shall preclude or restrict the further exercise of that or any other right or remedy. A person who is not a party to the Contract shall not have any rights under or in connection with it.

The mediation will start not later than 60 days after the date of the ADR notice. GOVERNING LAW AND JURISDICTION

The Contract, these Conditions and any dispute or claim arising out of or in connection with them or their subject matter or formation (including non-contractual disputes or claims), shall be governed by, and construed in accordance with English law, and the parties submit to the non-exclusive jurisdiction of the courts of England and Wales. 11.7 Chesizock, (being an individual) the Buyer dies or, by reason of illness or incapacity (whether mental or physical), is incapable of managing his or her own affairs or becomes a patient under any mental health legislation.

LIMITATION OF LIABILITY 7.2.12 IMITATION OF LIABILITY
Subject to clauses 8.2, 8.3 and 8.4, MQL's total aggregate liability under or in connection with any claims arising under these Conditions in any twelve month period, whether in contract, tort (including negligence) or otherwise, shall in no circumstances exceed the lesser of one hundred percent (100%) of the monies paid to MQL by the Buyer under these Conditions in the preceding twelve (12) months or £250,000.

Nothing in these Conditions shall limit or exclude MQ's liability for: death or personal injury caused by its negligence, or the negligence of its employees, agents or subcontractors (as applicable); fraud or fraudulent misrepresentation; or breach of the terms implied by section 12 of the Sale of Goods Act 1979; or defective products under the Consumer Protection Act 1987

MQL shall not be liable to the Buyer, whether in contract, tort (including negligence), breach of statutory duty, or otherwise, for any loss of profit or indirect or consequential loss arising under or in connection with the Contract.

MQL's total aggregate liability for direct damage to the Buyer's tangible property under these Conditions shall be limited to £1,000,000.

PORCE MAJEURE

Neither party shall be liable for any failure or delay in performing its obligations under the 8.4 FORCE MAJEURE

Neither party shall be liable for any failure or delay in performing its obligations under the Contract to the extent that such failure or delay is caused by a Force Majeure Event. A Force Majeure Event means any event beyond a party's reasonable control, which by its nature could not have been foreseen, or, it could have been foreseen, was unavoidable, including strikes, tock-outs or other industrial disputes (whether involving its own workforce or a third party's), failure of energy sources or transport network, acts of God, war, terrorism, riot, civil commotion, interference by civil or military authorities, national or international calamity, armed conflict, industrial action or restrictions imposed by any government authority whether at local, national or European level, malicious damage, breakdown of plant or machinery, disease, nuclear, chemical or biological contamination, sonic boom, explosions, collapse of building structures, fires, floods, storms, earthquakes, loss at sea, loss of possession of land, epidemics or similar events, natural disasters or extreme adverse weather conditions. 9. 9.1 9.2

NOTICES
